The poem clearly pinpoints the miseries, destruction, gruesome effects of the war, and the psychological implications of the war upon the masse causing trauma for the affected. Hopelessness, pessimism. blasphemy. revolt against governmentally established law and order, and most importantly the spiritual decline were the byproducts of this war. These all negative traits completely overlap the modern men. These negative elements that were prevalent in modern society forced Eliot to paint what he observed. The modern men had lost hope and were discontent about their lives. Therefore, Eliot determined to write about how modern men lacked spiritual strength. And how they had become spiritually empty. Modern men differed from their anterior counterparts. Hollowness and spiritual decline remain, throughout the poem, the subject matter of the poem in the long run.

1.1 Background of the study

The poem, "The Hollow Men" was written around 1925 by the then-prominent modern critic T.S Eliot in response to the after-effects of World War I upon the society. This war put the Western culture on stake almost pushing it to death. The war started in 1914 and ended in 1918 respectively was a huge antihumanist act in the history of humankind. Almost, every field of life was disturbed and suffered from its consequences. The war adversely affected the economy, education, 8nfea-structure, and other public service institutions. Destruction, desolation, destituteness. and extreme psychological implications cast by war tempted the writers of the

time to write what the war brought to the world. World undepressed financial, educational, moral, ethical, religious, political, and institutional crises. The war proved a blow to the culture and civilization. Such a situation grabbed the attention of Eliot to portray the scenario that he perceived during his lifetime. These serene conditions and the suffrage that his countrymen were going through including Eliot induced him to write up for this poem.

Moreover, his poem envisages social, political, cultural, and religious impacts that the war brought about inclusively technological disruption. The second epigraph is a representation of a guy namely "guy flawless" who was a catholic. He supported another catholic leader against the anti-Catholic legislation King Jams. In this regard, he plotted to blow up the parliament but was captured red-handed and sentenced to death. After all, the country celebrates its anniversary annually on 5th (Nov). The children knock on each door and ask for/request some pennies from the people to buy a scarecrow and burn it in the streets. The characters of both men represent hollowness and humanity, which is likely found in modern men too. Thus, Eliot resembles these modern men with those immoral and spiritually empty people of the past in the very prologue of the poem.

In the very start writer calls the modern men including himself hollow men and stuffed men. Hollow represents the inability and emptiness whereas stuffed reveals that the modern men are loaded with useless stuff that is unworthy.

The third line reveals that the minds of modern men are replete with bushes and straw. This is so pitiful that their intellectuality is no more. Why does the writer say that their minds are filled with straw? Just because the modern lacked wisdom and behaved foolishly.

Our dried voices, when we whisper together Are quiet and meaningless As wind in dry grass

Or rats' feet over broken glass In our dry cellar

In these lines, the poet explains that the voices that modern men produce are dry and meaningless. Their voice is so slow. This is why that is unheard of. This shows that their voice is the voice of those who are ignored. These modern men are the most ignored ones. Furthermore, all is meaningless and worthless whatsoever they speak. However, their speech is worthless no more than the sound of the rats' feet which are produced when they walk into the cellar over the broken glass.

Dried voices represent once more lifelessness. Although modern men are walking they are deadly walking. No matter all that they do, is of no use. Their activities are unproductive nothing, whatever comes out of their mouths, is appreciable and noteworthy. However, like the dry grass, they are dried souls, lacking the actual essence of being alive.

Having shape and yet being formless describes that they have no identity. And to label them with any identity would be an effort in vain because modern men were incapable of maintaining their identity for a long time. Throughout the years they lived under depression, uncertainty, and ambiguity. And regarding, their words and whatever they articulated, seemed colorless. Their words like bodies were hollow, for their words scarcely gave any meanings, whatever the reason be, modern men, however, are victims of hopelessness and utter frustration which snatched from them the beauty of life and their importance on the planet.

The reference of the fathers or of things who have died accepted the death boldly. Even those dead would call us the dead men. It won't be wrong to call us dead, because we are already deadly aliens. Do these stone-made statues receive the prayers of these dead men, these soulless men what they truly deserve to be called, worship that own raised stone images while letting the candle which temporarily enlighten them and then fades away after all? Here the poet may be indicating the temporary /ad hoc lifelessness of their spirit which dies away after a short period. They turn to pray but sooner they turn towards worldly actions. Their relationship with god is crippling. They could not stay connected to god for so long. Their relationship with their god is very likely to be the fading star in nature. This transient attitude symbolizes their weakness to stay persistent in other activities of life. They are not reliable owing to their changing behavior. These lines reveal their attitude that do not take any task solely and serenely no matter whether those activities are worldly or spiritual.

Stanza: the eyes are not here There are no eyes here In this valley of dying stars In this hollow valley This broken jaw of one lost kingdom.

This stanza conveys the message that modern men are blind. This valley means our land has lost enlightenment in its totality. In the absence of light, no one can see anything. Inclusively the inhabitant is blind. Then it would be effort in vain to perceive anything. And the kingdom has fallen victim to complete havoc. Destruction all around, but nothing remains attractive to glance at. Star detests to visit such an ugly land. This valley of blind people attracts no one. Dying stars represent the death of the souls of modern men. There is no more spiritual enlightenment not even the chances of spiritual upheaval seem to be in sight at length.

Every land earns a fence owing to its unique characteristics and its countrymen. Unfortunately, the kingdom of modern men was destabilized alongside its countrymen. Regarding, the lands earn the name "The Hollow Land, and its inhabitants as hollow men". They were spiritually powerless. Thus they remained in the pit of extreme darkness.
